Message from the Chairperson

As I look back on the past fiscal year, I am proud of what the Howard Community College Educational Foundation (HCCCEF) accomplished to support students as they pursued their education. The foundation raised a total of \$1,574,503, exceeding our fundraising goal! This accomplishment was only possible with the contributions of every donor listed in our annual report. Each donation makes a difference in the education of a student. Here are just a few examples:



For Leslie, three scholarships are enabling her to balance schoolwork and motherhood. With the additional financial support, she is able to pursue training as an emergency medical technician, with the long-term goal of becoming a nurse.

While Taylor chose HCC for its affordability, his scholarship has made all the difference. He has had the flexibility to pursue hands-on learning through a classroom collaboration with V-LINC, a nonprofit that creates customized adapted technology for people with disabilities. He and other engineering students built a customized "chariot" for a nine-year-old girl with muscular dystrophy. Now, his enthusiasm and experience with engineering will lead to a four-year university.

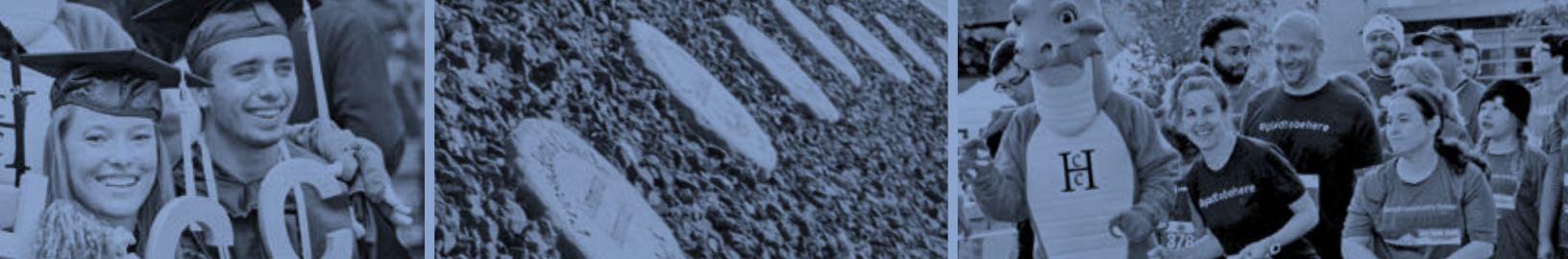
These are just two stories, and there are hundreds more. Through the generosity of donors, HCCCEF provided over \$1.5 million in scholarship and programmatic support, ensuring more students have the opportunity to pursue higher education. Our donations come from a variety of community donors, employee donors, grants, in-kind donations, and our fundraising events such as the HCC 5K Challenge Race, the Silas Craft Collegians Dinner at Hunan Manor, Vino Scholastico, and other smaller events.

I am especially proud that this year, HCCCEF achieved the successful completion of the Pathway Scholarship matching campaign. When the Howard County government provided a \$2.5 million grant in FY15, \$500,000 was set aside for a matching campaign. I am pleased that over 450 individuals, businesses, and organizations contributed, helping HCCCEF exceed its goal and raise \$504,196! It would not have been possible without your support.

In closing, I cannot thank our many donors enough. Your gifts of treasure ultimately transform students' lives as it removes the financial burden of the cost of education. I look forward to another year of funding student pathways to success.
